## Contract Provisions:

I/We understand that a non-refundable security deposit of \$75 will be due and payable prior to my child/ren attending the center.

I/We agree to pay the monthly tuition of

Two Days a Week = \$200 Monthly

Three Days a Week = \$300 Monthly

the first week of each month that my child is enrolled regardless of illness, absence, snow days or holidays. If my tuition is not paid before the second Wednesday of the month at 12:00pm, a late payment fee of \$15 will be added to my tuition.

Lil' SAINTS Preschool is for children 2 ½-years to 5-years of age. The operating hours for Lil' SAINTS Preschool are clarified according to the programs listed below.

\*\*Must qualify to enroll for Kindergarten or a Young 5's program for the 2021-2022 school year.

A minimum number of students must be made for each program option.

I/We understand that no refunds, credits or discounts will be given because of vacation, illness, snow days or absences. Full tuition is due each month my child/ren is enrolled in the program at Lil' Saints Preschool.

In the case that I/we choose to withdraw my child/ren from the program, I agree to give two weeks written notice.

Tuition rate may be subject to change at any time during my child/ren's enrollment with a written notice at least two weeks prior to the effective date.

**First United Methodist Member Discount:** Current members of the First United Methodist Church of Saline qualify for a 10% discount on enrollment for their oldest child. This discount is only applied to the monthly tuition. A legal guardian of the enrolled child must be a member of the church.

**Sibling Discount:** A family who enrolls more than one child in Lil' Saints Preschool qualifies for a 10% discount on the youngest attending child. This discount is applied to the monthly tuition.

A family may only apply one discount per school year. If a family meets the requirement for both discounts they may apply **one** discount that offers the higher value.

- Health Appraisal Form & Immunization Record
- Lil' Saints Preschool Parent Questionnaire

- Permission Form
- Signed Notification of Licensing Handbook
- Non-refundable Security Deposit/Registration fee of \$75 per family per year.
